- **Description of content:** This Communique covers electric mains-operated household washing machines and electric mains-operated household washer-dryers including those which can also be powered by batteries and including built-in household washing machines and built-in household washer-dryers.

This Communique shall not apply to:

- a) Washing machines and washer-dryers in the scope of the Regulation on Machinery (2006/42/EC) published in the Official Gazette No. 27158 dated 03/03/2009,
- b) battery-operated household washing machines and battery-operated household washer-dryers that can be connected to the mains through an AC/DC converter purchased separately,
- c) household washing machines with a rated capacity lower than 2 kg and household washer-dryers with a rated washing capacity lower than or equal to 2 kg.
- 7. Objective and rationale, including the nature of urgent problems where applicable: The purpose of this Communique is to establish requirements for the labelling of, and the provision of supplementary product information on, electric mains-operated household washing machines and electric mains-operated household washer-dryers including those which can also be powered by batteries, and including built-in household washing machines and built-in household washer-dryers related to the implementation of the Regulation on setting a framework for energy labelling (1369/2017/EU) published in the Official Gazette dated .../···/···and numbered ···..; Consumer information, labelling; Protection of the environment; Harmonization

8. Relevant documents: This Communique has been prepared based on the Commission Delegated Regulation (EU) 2019/2014 of 11 March 2019 supplementing Regulation (EU) 2017/1369 of the European Parliament and of the Council with regard to energy labelling of household washing machines and household washer-dryers and repealing Commission Delegated Regulation (EU) No 1061/2010 and Commission Directive 96/60/EC.

This Communique has been prepared on the basis of the Law No. 4703 of 29/6/2001 on the Preparation and Implementation of Technical Legislation on Products and the Presidential Decree No. 1 on the Presidency Organization published in the Official Gazette No. 30474 dated 10/7/2018.

9. **Proposed date of adoption:** The regulation will be adopted upon its publication.
