6.	内容简述: 修订强制性标准 SI 14988 第 1 部分以及自愿性标准 SI 14988 第 2 部分"儿童高脚椅的处理",替换为 SI 14988。 该拟议标准版本订采用了欧盟标准 EN 14988(2017 年 7 月),在该标准的希伯来语部分进行了一些国家修订。旧版和新修订版标准草案的主要差异如下:将两部分的要求合并为一项标准;增加邻苯二甲酸盐检测要求(国家章节 6.b);增加蚁醛检测要求(国家章节 6.c);采用新颁布的欧洲标准的要求。新拟议标准的所有要求均应作为强制性要求,国家章节 4.1 中要求的其他表述除外。旧标准以及新修订标准的有效期均为本拟定版本生效后 6 个月。在此期间,可根据旧标准或新修订标准对产品进行测试。

- **Title, number of pages and language(s) of the notified document:** SI 14988: Children's high chairs Requirements and test methods (56 page(s), in English; 7 page(s), in Hebrew)
- 6. **Description of content:** Revision of the Mandatory Standard SI 14988 part 1 and the voluntary standard SI 14988 part 2, dealing with children's high chairs, to be replaced with SI 14988. This proposed standard revision adopts the European Standard EN 14988: July 2017, with a few national deviations that appear in the standard's Hebrew section. The major differences between the old version and this new revised draft standard are as follow:
  - Combines the requirements of two parts into one standard;

- Adds a requirement for phthalates test (national section 6.b);
- Adds a requirement for formaldehyde test (national section 6.c);
- Adopts the requirements of the newly adopted European Standard.

All requirements of the new proposed standard shall be declared mandatory, except the additional words required in the national section 4.1.

Both the old standards and this new revised standard will apply from the entry into force of this proposed revision for a period of 6 months. During this time product may be tested according to the old or the newly revised standards.

7. Objective and rationale, including the nature of urgent problems where applicable: Protection of human health or safety

Both the old standards and this new revised standard will apply from the entry into force of this proposed revision for a period of 6 months. During this time product may be tested according to the old or the newly revised standards.
